Session: 'Reset Required? Evaluating the first two years of the Media Freedom Coalition'

Date: Wednesday 9th February 2022, 16:00-18:00 (Tallinn time)

Summary of session: This event will present and discuss the findings of an independent academic evaluation of the Media Freedom Coalition (MFC), reviewing its progress since its inception in 2019. Today's media freedom issues will be explored through the lens of the MFC's response to them, with the aim to identify key areas for improvement or development of the MFC to strengthen its work moving forward.

Chaired by **Jodie Ginsberg**, Chief Executive Officer at Internews Europe, this facilitated discussion will be framed around thematic sections of the evaluation report, also entitled 'Reset Required? Evaluating the first two years of the Media Freedom Coalition'. These themes include: 'Promoting Accountability in responding to Media Freedom Violations', 'Internal Democratic Backsliding and Accountability within the MFC' and 'Media sustainability - what is the MFC doing to support?'.

A core panel, including representatives from the evaluation team, the MFC's Consultative Network, and the MFC Coalition, will be present throughout the event. They will respond to intervening speeches made by selected media freedom and development experts, who will be introducing the themes, and key concerns related to them, in turn. **Dr Bahia Tahzib**, Human Rights Ambassador of the Kingdom of the Netherland, the next MFC co-chair, will provide the closing remarks.
